The money from sponsorships and donations will not go to the Usaveme platform, and we will not take a cut; 100% of the money will go to the child or organization.

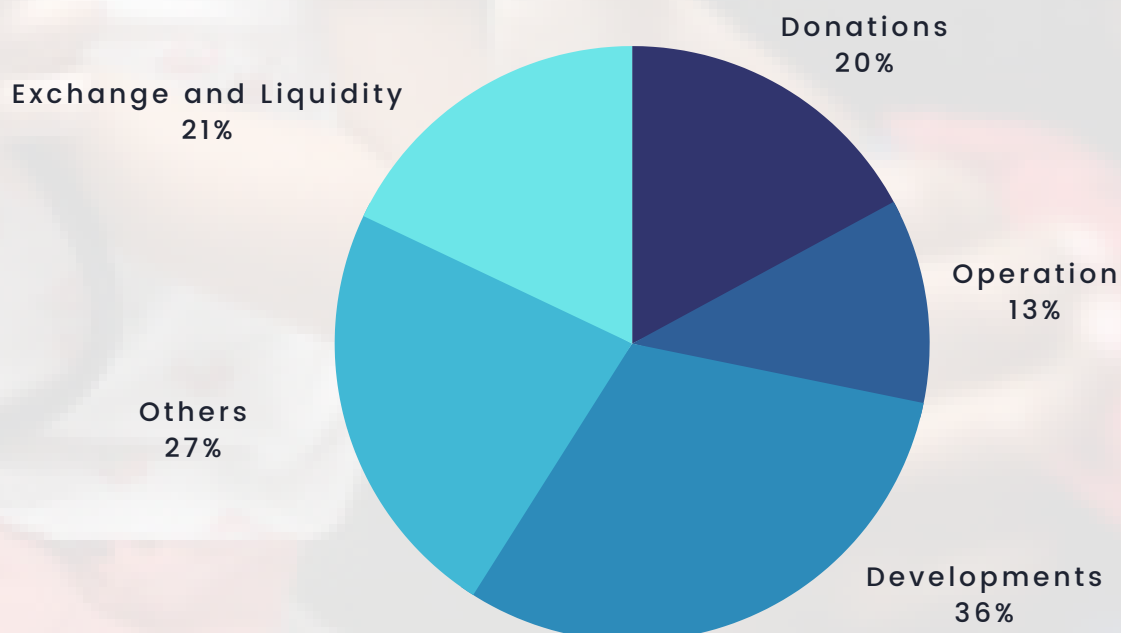
Strong platform
